## Types of Legacy Gifts



### Unrestricted Gift or Bequest

Money or property donated during the donor's life ("Gift") or after the donor's death ("Bequest") that is given with no restriction on how the donation is to be used.

### Restricted Gift or Bequest

Money or property\* that is designated for a specific purpose. (Check with pastor or GMB for options.)

### Charitable Gift Annuity

An irrevocable gift that provides you or a designated recipient a fixed income.

\*Covenant does not accept real estate property.

## Ways to Make a Gift



**Bequest in your Will** - a designation of a gift to a charitable organization in your will.

**Insurance Policy** - specifically designates Covenant Presbyterian Church as the official designated primary beneficiary.

**Retirement Benefit Plan** - a donation from the proceeds of a 401k plan or IRA to Covenant Presbyterian Church.

**Charitable Trust or Gift Annuity** - set up through the Presbyterian Foundation or other foundation.
